### Introduction of the company

The so called "Stableonegroup LTD" was incorporated on the 11th of May 2022 under company no. 14099508.<sup>1</sup> Registrated office address 85 Great Portland Street, London, England, W1W7LT, company type private limited (LTD).<sup>2</sup>

Listed Company Director, Michael Pardos, correspondence address 106 Long Lange, Grays, England, RM16 2PP, date of birth January 1982, nationality American, country of residence England.<sup>3</sup>

### Short description of Projects, Services and Products

Farm house – Polygon // Matric Mining "game"<sup>12 13</sup>

Dragons Den – related to product Stableone, please see attachement 7 and 8 for further detailed explanation. Status unclear.

Srocket – related to product Stableone and later for version Stablefund. DAO Token, used to pay dividends on any token holder and investors of Stableone or Stablefund who bought this token. Status collapsed to due massive sales and exit liquidity<sup>14</sup>

Stablefund formerly known as Stableone – available as App on Apple Store and Google Play<sup>15</sup> or the above links in the past, directly via browser. Wallet and APP

with staking rewards for BUSD, Matic and BNB, in the original currency. Provided rate 1,5% daily. Earnings claimed to be generated by the product owner via automated trading.<sup>16 17</sup>

SFUSD – new stablecoin, former value 1 USD, provided by Stableonegroup LTD. Coin was supposed to be used as replacement for earned rewards in Stablefund APP or Wallet. Original coins (BUSD, BNB, Matic) had been replaced by the Stableonegroup LTD. Status collapsed due to fraud and exit liquidity.<sup>18</sup>

### **Identity theft**

Due to the community investigations, we couldn't confirm "Michael Pardos" identity or location. Neither the company nor the private location are legit. The provided details (also to the UK authorities) seem to be incorrect and misleading. Mr. "Michael Pardos" showed his passport to the community, claiming that it is him. Gathered documents show a criminal record<sup>19</sup> <sup>20</sup> assigned to the person/passport in the US.<sup>21</sup> In addition his former Telegram account<sup>22</sup> and a

signature on an invoice, show that he also uses the name "Ray Kiehls" <sup>23</sup>. It is unclear who he is.

### **Running a Ponzi**

The referring smart contracts for BUSD24 and BNB25 on the blockchain, do not show revenue injections by Stableonegroup, LTD. Therefore, we can assume that all withdrawals have been paid out of investor funds. The calculation provided on the former Stablefund website or the mobile app had only been calculated on paper. There is no evidence of bot or manual trading as claimed by owners.".

The referring smart contract for Matic<sup>26</sup> shows injections of funds. It is unclear to us, where those funds had come from. Due to missing transparency and data, we do assume that those injections of "revenue" were only due to swapping BUSD into Matic within those two contracts, to stimulate the community.

## Active FRAUD Plant Misappropriation Wash trading<sup>27</sup> Curse Manipulation

"Mr. Michael Pardos" aka "Ray Kiehls" withdrew all funds and all contracts three months ago, without proper notice. All funds had been transferred multiple times to several wallets and exchanges. claimed that he removed the funds to protect them so that he could refund all investors their initial capital back. After implementing Version 2 of Stablefund, he introduced his Stablecoin SFUSD as a replacement for the original coins that had been invested. He also claimed that rewards would be in SFUSD vs the original coins invested. As of today, there

have been no significant refunds, only a handful of small amounts have been returned so that he could claim "refunds are being done". Over 90 percent of investors have yet to receive a refund in any amount. Due to his own actions, Michael Pardos (Ray Kiehls) caused the collapse of SFUSD and the related DAO token Srocket (the majority of tokens were held by him and his own team). When liquidity was pulled, it caused the price to collapse. of the original coins/investments and as a future reward token. Till today no major investor did receive any major investment back. Due to several reasons

# False claims and misleading commercials to spin a positive narrative

To keep the motivation high and gather more investors into Stablefund, several attempts had been created, by "Michael Pardos" aka "Ray Kiehls" to spin an ongoing positive narrative:

- Advertisement on Time Square
- Advertisement on UK Taxi services
- Debit card
- Dubai Event
